The fabric performance tests were conducted in accordance with ASTM E891 & ASTM E903-96: Solar Transmittance (Ts), Solar Reflectance (Rs), Solar Absorptance (As), Visible Reflectance (Rv), and Visible Transmission (Tv). Glass performance tests for Solar Heat Gain Coefficient (SHGC) were conducted using the Lawrence Berkeley National Laboratory Window 7.3 NFRC certified software and a standard commercial glass makeup of Double Glazing 6 mm / ½" air / 6 mm with low E on surface #2. Results for SHGC were obtained using the center of glass. Acoustical performance tested in accordance with ASTM C423-09a: NRC is Noise Reduction Coefficient, SAA is Sound Absorption Average. Care & Handling

Remove dust with vacuum cleaner or compressed air. Do not scrub. Do not use solvents or any abrasive substance which might damage the coating of the fabric. The front side of Avila is treated with DURAGUARD® Fabric Protector and can therefore be spot cleaned by gently blotting with a sponge or soft brush dipped in lukewarm soapy water using a mild detergent. The foam coating on the back side should not get wet. A dry chemical sponge or clean white pencil eraser can be used to remove small stains.
